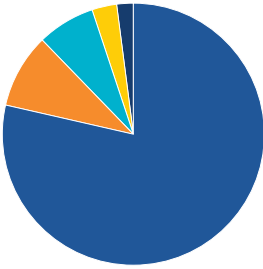

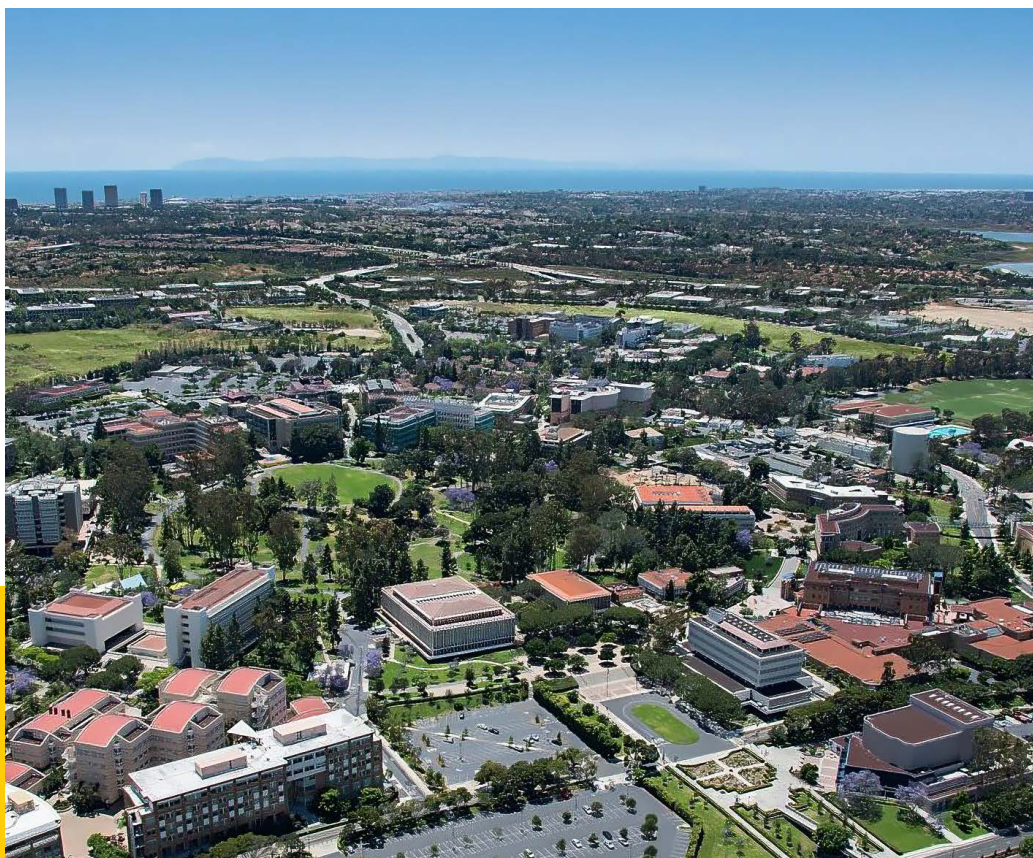

Scholarships

Every admitted J.D. student is automatically considered for the UC Irvine Law Scholarship, which is renewable for up to three years (six semesters) of full-time enrollment, provided the student maintains good academic standing. To further support accessibility, UC Irvine Law also offers need-based grants to help reduce the debt burden for students facing significant financial hardship. Eligibility is determined using information from the FAFSA or California Dream Application and is assessed before the first year. These grants are automatically renewed for up to three years (six semesters) as long as the student remains enrolled full-time. This process allows students to plan financially for the entire duration of their J.D. program.

REQUIREMENTS FOR FIRST-YEAR APPLICANTS

An application will be considered complete and eligible for review by the Admissions Committee when the following items are received by the deadline dates specified in the application instructions:

- › Complete application
- › Undergraduate and graduate transcripts from all postsecondary institutions attended
- › Credential Assembly Service Law School Report (CAS Report)
- › Official score reports for all standardized test scores (LSAT and/or GRE)
- › A minimum of two (no more than three) letters of recommendation (must be included in your CAS Report)
- › Resume or Curriculum Vitae
- › Personal Statement (750-word limit)
- › Why UC Irvine Law? Essay (750-word limit)
- › Character & Fitness/Conduct Statement if applicable
